Please read this information when considering the August-October 2018 Day Training Program:

- You need to attend **all** sessions to be eligible to move onto student placement and to meet the requirements of the training program.
- There is an e-learning requirement (approx. 3 hours per module), except for ASIST (module 1)
- Attend a Connect Referrals presentation (2 hours) and an Orientation and Observation Shift (2 hours)
- Student placement
16 hours supervised phone room work. Day, evening and weekend placement shifts are available.
Completion of Placement hours is over 4 weeks.
- Additional individual and group supervision sessions are mandatory during the probationary period.
Business and after hours are available.
- Mandated PD sessions need to be attended during the probationary period. These are usually held after hours. The dates for these sessions will be advised once probationary period is commenced
- The cost for the training program is \$950.00.
